The Selectmen's Meeting was called to order by Charlie Goulet @ 3:31 pm.

APPOINTMENTS: **Denis Corbeil:** Card Property: Talked about property updates with health officer, what's been done and what's being done. (Property being slowly worked at cleaning up.) Would like to look into easements, are they affected?

Amy Goyette: TCCAP Connect; Came to discuss adding a mobile access unit to the North Country for TCCAP resources. Ideally would like to set up somewhere in town, looking at a week at a time-however they would need access to bathrooms. They would be able to offer access to a multitude of services like senior meals, transport, service link, fuel assistance and more.

Building on Class VI: 231-001 driveway permit needed, need to send letter regarding proper documentation. Reached out to new owner and have complete application for building on class VI road. (Tabled until next meeting)

Center Cemetery: There is a concern of water running from the Big Rock property that run along the back of the cemetery, starting to cause washout. Macdonald and Juergens will take a look and report back.
