

Selectmen's Meeting Minutes
September 11, 2023
Fuller Town Hall @ 3:30 pm.

Selectmen present: Clayton Macdonald, Charlie Goulet **Others present:** Suzanne Goulet, Jennifer Caron
Meeting was called to order: 3:30 PM *(Macdonald)*

APPOINTMENTS:

Maryann Lister: Came to discuss the unregistered dogs at one residence on Mason Road. She sent a letter requesting the dogs be registered and show proof of rabies vaccine within 30 days and its been 30 days as of 8/31/23, and no dogs have been registered and she has received no contact from the owner. There are 20 dogs in total.

Mason Road Dog Issue: Maryann also comes in along with other residents of Mason Road to express concern of the dogs safety, health, their barking all night every night, (videos emailed to town) and dogs getting loose and running onto others property.

Mrs. Mockler has had two of the dogs running into her yard loose. She is concerned for her own pets safety. She also complains of the endless noise. Mr. Mockler lives close by to the area of concern and stated that the barking is unruly all day and night, and the smell is unbearable.

Jim Lee, has also had these same issues. Other local residents came to express these same concerns and also the putrid odor coming from the residence. They believe no one is any longer living at the residence but rather just allowing dogs to use the home.

Per RSA 466.31D Nuisance Dogs has a section stating nuisance dogs "barks for sustained hours or overnight", this would allow the town to pursue this issue as needed.

There are many concerned citizens on Mason Road.

Jim Lee- From the Health Officer Stand Point: The dogs are getting food, shelter and water, so due the town can nor act on any "abuse" or "cleanliness" concerns. The "nuisance" dog issues we can move on.

Jim expressed concern about making moves to resolve this issue now and not later.

Pleasant Valley Road Dog Issue: A group of citizens came into to express a high concern for 2 dogs that are both believed to be violent, living on the trailer park. The are vicious in nature and are repeatedly getting loose, two residents have been bit by these dogs. The citizens have expressed their concerns to the trailer park owner and manager. The trailer park is under new ownership and they are in the process of information gathering about who, and what is living in the trailer park at this time, and establishing rules to go with. The breed of dog is Pit bull, and Pit bulls are not allowed in the park per the new rules. Citizen explained there is an open case with state police, state police normally do not get involved but, they will respond for vicious dogs

There was discussion about the need to potentially update the Town Dog Ordinance.

Suzanne:

Boston Post Cane: Plaques being made to hold everyone's name. Looking for all the names we have on file!

Snooky Bench: The Post Office would like to install a bench in honor of the late Snooky Hurley. *(Motion to approve bench, Macdonald, Second Goulet)*

Kimball Hall: Some citizens have called in to express the future on Kimball hall. Jenny has explained to them all it is not a town building and out of our hands at this time. She encouraged them to bring their concerns to town meeting as well.

Community Power: Clayton and Suzanne attended a meeting in Berlin, this is brand new and just starting so not a lot of information to share at this time.

Bordeau Rd. Ditches: Plan for the culvert needed. Charlie would like to see a structure set up to maintain these. Charlie will write out plan for culvert maintenance for all culverts.

62 Christie Rd: Denis Maguire sent in two quotes for the tree work that will need to be removed, the trees damage is believe to be cause by road work done by the town. He has one bad tree threatening the garage and another that can potentially cause damage if not resolved. The trees were groomed heavily for power lines, leaving one side (side closest to the garage) much heavier than the other.

Grootys gave a quote of \$5,800.00

Allan's Stump and Tree gave a quote of \$7,000.00

(Charlie Goulet made a motion to give \$1,000.00 to help Denis, Clayton Seconded) with the tree removal as there is one major tree that must come down via crane, it was possibly destabilized by the work done on the Christie Road approx. 3 years ago.

Building Certificate/Extensions: There are a few revisions that need to be made to the building certificate extensions portion. The cost will now appear as follows: \$10-improvement \$20 extension; \$10-residential \$20-NEW residential. *(Motion to approve revision of costs Clayton Macdonald, seconded Charlie Goulet)*

Playgroup/Parks: There is a new playgroup free to all public utilizing our public spaces on Fridays, they are looking for the ability to put up some baby gates at the Library for a short time to contain the little's. *(Clayton made a motion for approval, Charlie seconded.)*

PSNH Cases 2018/2019: So far 2017 Cases has be resolved, currently they are work on 2018 & 2018. The agreement with Sansoucy and the 50 towns to continue services contract is needing to be signed. *(Clayton made a motion to sign the agreement, Charlie seconded.)*
