Meeting was called to order: 4:20PM (called to order Clayton Macdonald)

Wayne Hall/Dog Issues/Dog Officer: Will revisit Hall was unable to make the meeting.

Brauer: Brauer is at the meeting to speak to the board about becoming a full member of the Planning Board. With minimal discussion regarding the open seat the board made the motion to bring Michael Brauer onto the Planning Board. (Macdonald, Juergens)

Micheal took his oath with Maryann Lister in front of the board.

Maryann Lister: Maryann came to discuss waiving interest & penalties. Currently there is a waiver for up to \$15 in interest and penalties. Maryann is proposing that we raise that from 15\$ to 25\$. The plan would be to use this in a case by case scenario, and would not apply to those with back taxes. *RSA 76:B (Interest)*

Payment Plan: Tax Payment Agreements, accept payment through NHTCA. After some discussion it is realized this is basically what is already allow.

Maryann also will call and find out about the camper registrations and what options we have to monitor this and create less abatement. Is this even an option? This would to be able to hopefully find an alternate to creating numerous camper abatement.

Suzanne:

Nextera: The town will be receiving a credit from Nextera in a check form in the amount of \$5,936.47. (Macdonald made a motion to accept agreement, Juergens seconded) The credit is coming due to the contract coming to an end with them but they did not remove all the accounts from Nextera when the contract ended, some were removed, some were not. Therefore we incurred excess charges due to 3rd party high rates that we should have no longer been in contract with.

Japenese Knotweed: There is a substantial amount of knot weed on one of the islands on the Connecticut. What can be done, if anything? Mike Lynch mentioned some near the mill as well. Will revisit when time allows.

Josh Phillips/End of Maintained Section of Percy Rd: Josh is looking to see if the "End of Maintained Road" section could be moved further up the road on Percy Road. The board would like more information, Why would he like to have this done, the Board will invite him to a meeting.

Roads: Told Brault not to do Old Mill Road-This does not need to be done at this time due to paving coming later in the season.

There has been a lot of discussion on the Roads and some of their desperate need for attention. There will be a Public Hearing held July 24th at 6:00 PM. This will be the time to discuss potential costs, priority roads, paved/gravel, should is even be a town road, etc.
