Suzanne:

Excavator/Funds/Cost/PH: The Transfer Station is looking to purchase a Kubota Excavator the cost is \$65,367 from Champlain Valley Equipment. The funds for this will in come from the Recycle Revolving Fund. The purchase of this equipment will be open for discussion at the Public Hearing for Roads and Equipment. (The board approves the purchase of the Excavator, Clayton Macdonald, Harry Juergens) (Charles Goulet to abstain himself from the vote)

Paid Off TAN Loan: The TAN Loan is Paid Off in Full, the interest for the loan was \$3,533.33. It was paid in full on 6/27/24.

KRT Appraisal: Gary Fournier will be retiring in 2026 therefore we need to start considering a replacement for our assessing. The town of Monroe recommended KRT which is who they have contracted with after they lost Gary when he retired with them.

Waterline Inspection: Mike Lynch provided a quote for this after consideration of the quote the Selectboard has decided to take on the project themselves, they will take a training course and make a plan of action following the training, this will begin ASAP as this is to be completed by October.
