Call to Order: 3:30PM by Charles Goulet

Mike: Went over the town's roads preliminary report. He will come back in with a cost for the priority 1 roads.

Mr. Stinson returned only 5 signed Municipal Safety Handbook. (This is a requirement of all employees that work in the field).
