Town of Stratford Board of Selectboard Meeting Fuller Town Hall @ 3:30 PM June 16, 2025

Call to Order: 3:30PM by Harry Juergens

Selectmen present: Harry Juergens and Ron Scott, Jr

Others present: Suzanne Goulet, Vanessa Toner and Scott Dissler

Dissler: Mr. Dissler met with the Selectboard today to discuss his interest in joining the Planning Board. The Board had a few questions regarding his motivation and what he believes he can contribute to the board. Mr. Dissler explained that he finds the Planning Board's work very engaging. He has attended several meetings and has found them educational, particularly in learning about specific RSA requirements, as well as the roles and limitations of local government. Following the discussion, a motion was made to appoint Mr. Dissler to the Planning Board. The motion was seconded by Ron A. Scott, Jr.

Suzanne: The Board received an update regarding the ongoing junkyard situations at the Marcy, Cheney, and Maximov properties. The Maximov property is currently in transition as it is being sold, and per the sale agreement, the property must be cleaned up; this matter remains in progress. The Marcy property has seen significant improvement, including the removal of a vehicle and a camper, and will continue to be monitored for compliance. The Cheney property has also been cleaned up, and the Board will conduct periodic checks to ensure the issue does not recur. Clayton MacDonald was not present to discuss the Christie property, and that conversation will be postponed until the Chairman returns in a few weeks. Ms. Goulet reiterated that no road work—including pothole filling or any alterations—should be performed without prior discussion and approval from Road Agent Mr. Lynch. She also noted that Mr. Lynch has submitted a road log to keep the Board informed of recent activity. The Board discussed a request for an additional speed sign on Bog Road but advised against installing one at this time. Lastly, the Board reviewed the job description for the Sewer and Water position and is satisfied with its content; Ms. Goulet will reach out to other municipalities for guidance on how they attract qualified candidates for public works roles. Motion was set forth to table it for further review and it was approved.
